EMPLOYMENT LAW SUMMIT

RI SHRM and The Employers Association of the Northeast (EANE) present this annual Employment Law Summit for HR professionals, organizational leaders, and law practitioners to stay up to date on the rapidly changing state and federal legal landscape. Past programs have included interactive trainings and presentations on the topics of reasonable suspicion, pay equity, immigration, workplace governance initiatives, EEO policies and compliance, and employee relations and investigations. (120-200 attendees annually.)

DIVERSITY CAFE

Led by the Diversity Committee of Rhode Island SHRM, Diversity Cafe is designed to facilitate connections and conversations focused on diversity, equity, and inclusion challenges and trends. Participants are provided a selection of facilitated table discussions on topics such as DEI in workplace and community settings, LGBTQIA+ allyship, and Anti-Racism. (65-80 attendees annually.)
